SWEEPSTAKES AND PROMOTION DESCRIPTION

The UnitedHealthcare Lumen Annual Preventive Checkup Sweepstakes (the "Sweepstakes") has a promotion period that is announced on or about March 1, 2025, at 12:01 a.m. Eastern Time ("ET") and ends on September 30, 2025, at 11:59 p.m. ET (the "Promotion Period"). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects.

ELIGIBILITY

The Sweepstakes is open only to Lumen employees, spouses and their dependents covered under a UnitedHealthcare plan. Void where prohibited or restricted by law.

SWEEPSTAKES ENTRY

To enter, simply get your annual preventive checkup between January 1, 2025, and September 30, 2025. For entry into the Sweepstakes without completing the action above, mail a 3" x 5" card containing your complete name, address, phone number and date of birth in an envelope to: UnitedHealthcare *Lumen Annual Checkup* Sweepstakes 2025, 9800 Health Care Ln., Minnetonka, MN 55343. Mail-in entries must be postmarked by September 30, 2023, and received by October 15, 2025. All entries are the property of Sponsor and will not be returned. By May 31, entries will have three chances to win, By July 31, entries will have two chances to win and by September 30, will have one chance to win. **Limit one (1) entry per person.**

The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. In the event a dispute regarding the identity of the person who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information or by any technical or human error which may occur in the processing of the entries in the Sweepstakes.

WINNER SELECTION

A random drawing will be conducted from among all eligible entries received by the end of the Promotion Period. The potential prize winners will be notified through mail. Sponsor has no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within ten (10) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be

selected. Sponsor, in its sole discretion, will attempt to contact potential winner of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified, and an alternate prize winner may be selected. **The odds of winning depend on the number of eligible entries received.**

PRIZES

Sweepstake's entrants are only eligible to win one of the fifteen prizes. A prize is not redeemable for cash, nor is a substitution for the prize allowed.

Prize winner is solely responsible for all federal, state and/or local taxes, and the reporting consequences of those taxes and for any other fees or costs associated with the prize. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these official rules or disruptive manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

RELEASE AND LIMITATION OF LIABILITY

Entrant further agrees that in any cause of action, Sponsor's liability will be limited to the cost of entering and participating in the sweepstakes, and in no event shall Sponsor be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.

CONSTRUCTION

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

GOVERNING LAW/JURISDICTION

Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of or connected with this sweepstakes or any prize awarded shall be resolved under the laws of the State of Minnesota, United States, without respect to any conflict of law issues, and entrant agrees that such shall be resolved individually, without resort to any form of class action, and exclusively by a court of competent jurisdiction in the State of Minnesota.
